This agreement issued for the above date is between the Wadsworth Hunt Club (WHC) Board and club member (print name) _____. The WHC agrees to reserve the noted facilities, located at 8445 Leatherman Road, Wadsworth, Ohio. The Member agrees and acknowledges the following:

1. The member reserving club grounds must familiarize him/herself with the WHC's "Grounds Operating and Use Rules" and "Constitution" and ensure all rules and regulations are followed.
2. The member will be held liable and responsible for the actions of their guests and their children; and, in addition will be financially liable for all damage.
3. Club member making the reservation must be present the entire time of the event.
4. All fees must be submitted with the reservation request. The security deposit shall be \$50.00 and the reservation fee shall be \$25.00 for use of pole barn and grounds. (Note: no reservation fee if reserving just the grounds.)
5. If member decides to cancel, or if request is denied, all funds will be returned.
6. The member is responsible to obtain a signed waiver from all guests prior to the start of the event. These signed waivers must be submitted to the WHC board prior to the security deposit being refunded.
7. Any member reserving club grounds must remove all garbage and rubbish from the grounds within 48 hours. The area must be left clean and the facilities must be returned to "as found" conditions or security deposit will be forfeited.

8. Music and loud speaker volume must be reasonable at all times so as to not constitute a nuisance or result in complaints to local authorities. There shall not be any music played or public address system used outside the pole barn after 10:00 pm.
9. Other than WHC board sponsored activities, members or guests may not use club grounds for financial gain.
10. The member reserving club grounds must be aware of and comply with the rules and regulations that are required by the State of Ohio Department of Liquor Control. Additionally, individuals under the influence of alcoholic beverages, stimulants, or depressants are prohibited anywhere on the Grounds.
11. Fires are permitted only in the designated areas, or in proper containers. All organizations must provide their own firewood. There will be NO cutting of live trees for firewood on club Grounds.
12. No motorcycles, mini-bikes, snowmobiles, ATV's or any other similar motorized recreational vehicle, or horses shall be operated or ridden upon the club Grounds. Vehicles can be used as a means of transportation but must stay on roadways and parking areas.
13. All guests are not permitted to enter onto any adjacent property.
14. Gun and archery ranges may not be reserved or used by club members for such purposes during the times of reservation.
15. Chairs and tables are NOT to be removed from the inside of the pole barn without the express written permission of the Board. If permission granted, all tables and chairs must be returned to their original location.
